User Agreement

This Agreement sets forth the terms and restrictions regarding the use of the First Unity Spiritual Campus (“First Unity Spiritual Campus”) web site (“FirstUnity.org”), by you, a user of FirstUnity.org, and the entity you represent (hereinafter collectively “you” or “your”). By using FirstUnity.org in any manner, you agree to all terms and conditions contained or referenced in this Agreement. This Agreement applies only to your use of FirstUnity.org and does not change or alter any other agreement between you and First Unity Spiritual Campus. By using and accessing FirstUnity.org you indicate that you have read and understand this Agreement and agree to be bound by this Agreement. If at anytime you do not agree with this Agreement, your sole recourse is to not use, or stop using FirstUnity.org. Viewing any page other than this Agreement and the FirstUnity.org home page at www.FirstUnity.org constitutes use of FirstUnity.org, agreement with this Agreement, and acceptance of this Agreement by you.

Section 1

This Agreement

Section 1.01 – Amendments, Modification and Change

First Unity Spiritual Campus reserves the right, in its sole discretion, to amend, modify or change this Agreement at any time without prior notice to you. You should visit this page periodically to review the current Agreement. Your continued use of FirstUnity.org following the posting of any changes to this Agreement constitutes acceptance of those changes.

Section 1.02 – Eligibility

You must be of legal gaming age within the state which issued the permit or license or the state in which the authorized organization is located for any raffle in which you participate. All federal, state and local laws and regulations apply.

Section 2

Intellectual Property and the Protection Thereof

Section 2.01 – Patents

FirstUnity.org is United State Patented and the intellectual property of First Unity Spiritual Campus. This intellectual property includes, but is not limited to, the methods, processes, procedures, software, internet technology, web design, page layouts, source code, and all other intellectual property rights covered under United States intellectual property law and the United States Patent Office.

Section 2.02 – Copyrights

FirstUnity.org is the Copyright of First Unity Spiritual Campus. All rights reserved worldwide.

Section 2.03 – Trademarks

First Unity Spiritual Campus and FirstUnity.org are the trademarks of First Unity Spiritual Campus. First Unity Spiritual Campus may have, from time to time, other trademarks and registered trademarks. Marks and trade names not owned by First Unity Spiritual Campus and mentioned on FirstUnity.org are the property of their owners. Using the First Unity Spiritual Campus TM mark and other First Unity Spiritual Campus intellectual property such as logos, slogans, trade dress, and graphic symbols on packaging, products, or services requires express written permission from First Unity Spiritual

Campus. Use of confusingly similar or disparaging terms is a violation of our intellectual property rights.

Section 2.04 – Ownership and Use of Web Site Information

All information, materials and software on FirstUnity.org, except noted third party materials, are the copyrighted work of First Unity Spiritual Campus and are protected under United States and worldwide copyright laws and treaty provisions. You may download, view, copy and print documents (such as, white papers, press releases, services, etc.) from FirstUnity.org subject to the following: any such use is solely for informational, non-commercial use; you may not modify or revise documents in any manner; you must keep and plainly display all copyright and other proprietary notices, in the same form and manner as on the original; you must display a statement that the materials are used solely with the permission of First Unity Spiritual Campus. First Unity Spiritual Campus reserves the right to revoke its authorization at any time, and your use shall be discontinued immediately upon notice from First Unity Spiritual Campus. Section 2.05 – Non-Disclosure and Confidentiality

You acknowledge that you will have access to certain confidential information of First Unity Spiritual Campus through your use of FirstUnity.org concerning but not limited to First Unity Spiritual Campus business, plans, patents, patents pending, customers, users, technology, intellectual property, and proprietary software. You agree that you will not use in any way, for your own account or the account of any third party, except as expressly permitted by this Agreement, nor disclose to any third party (except as required by law or to the attorney, accountants and other advisors of that party as reasonably necessary), any confidential information of First Unity Spiritual Campus and intellectual property of First Unity Spiritual Campus, and will take reasonable precautions to protect the confidentiality of such information. You shall not

disclose FirstUnity.org except to persons authorized in writing by First Unity Spiritual Campus, except as otherwise expressly permitted under this Agreement. You shall hold FirstUnity.org in strict confidence and shall not duplicate, use or disclose FirstUnity.org, except as otherwise expressly permitted under this Agreement. FirstUnity.org shall be deemed a trade secret of First Unity Spiritual Campus as defined under applicable state statute. Title to FirstUnity.org, including ownership rights to patents, copyrights, trademarks, service marks and trade secrets in connection therewith shall be the exclusive property of First Unity Spiritual Campus. You shall neither contest nor aid in contesting the ownership or validity of the patents, trademarks, service marks, copyrights, and trade secrets of First Unity Spiritual Campus in connection with FirstUnity.org. You shall use and disclose FirstUnity.org only for the exclusive purposes of selling and purchasing raffle tickets using FirstUnity.org, advertising using FirstUnity.org, sponsoring raffles using FirstUnity.org. You shall not use FirstUnity.org for any other purpose without advance written authorization by First Unity Spiritual Campus. You shall not solicit or request (directly or indirectly) any third party to design, develop, produce or provide any Technology similar to or competitive with FirstUnity.org, without the advance written approval of First Unity Spiritual Campus.

Section 2.06 – Non-Competition

During your use of FirstUnity.org and for two years thereafter, you shall neither (directly or indirectly) (i) promote, advertise, market, provide or distribute any Technology similar to or competitive with FirstUnity.org, nor (ii) engage in any activity in competition with or adverse to First Unity Spiritual Campus, or the business of First Unity Spiritual Campus, without the advance written approval of First Unity Spiritual Campus.

Section 2.07 – Fees and Penalties

You hereby acknowledge and agree that FirstUnity.org derives independent economic value (actual or potential) from not being generally known to other persons who can obtain economic value from its disclosure or use and not being readily ascertainable by proper means by other persons who can obtain economic value from its disclosure or use; is the subject of reasonable efforts

under the circumstances to maintain its secrecy; and is a trade secret as defined under applicable state statute. If you are found to be in violation of Section 2 (Sections 2.01, 2.02, 2.03, 2.04, 2.05, 2.06, 2.07) in whole or in part you agree to pay First Unity Spiritual Campus one billion dollars in United States denomination in addition to consequential, punitive, civil, criminal, and statutory damages that may be applicable by governing law and any additional fees that may be incurred in the collection thereof. This is to protect First Unity Spiritual Campus and maintain the value of FirstUnity.org for all users.

Section 3a

Raffles

Section 3.01a – Authorized Organization

To use FirstUnity.org to sell raffle tickets you must be a bona fide authorized organization. An Authorized Organization is defined in part to include bona fide religious or charitable organizations, bona fide educational, fraternal or service organizations or bona fide organizations of veterans or volunteer firefighters that operate without profit to their members and qualify to offer raffles by governing law. No other individual or type of organization is permitted to use FirstUnity.org to sell raffle tickets under this Agreement or governing laws and regulations. Only an Authorized Organization can sell raffle tickets using FirstUnity.org.

Terms of Raffle Ticket Sale and Purchase

Section 3.02a – Ticket Sale and Purchase

FirstUnity.org is a closed loop network that requires you to become a registered member and user before you can sell or purchase raffle tickets using FirstUnity.org. All raffle ticket sales and purchasing transactions using

FirstUnity.org must occur among registered members with the exception of advertised offline raffles and offline ticket sales transactions that do not occur on or through the use of FirstUnity.org.

Section 3.03a – Taxes and IRS Rules

All winners shall be responsible for any and all federal, state and local income or excise taxes, fees, assessments and like charges associated with prizes and winnings. All cash prizes will be paid net of applicable income tax withholding. The IRS requires that income tax withholding on prize values of \$5,100 or greater must be paid upon award and distribution. Government rules governing withholding can change without notice. The IRS has taken the position that amounts paid for chances to participate in raffles, lotteries or similar programs are not gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution. It is your sole responsibility to pay all applicable taxes that may be incurred or that may arise from your use of FirstUnity.org and the selling and purchasing of raffle tickets using FirstUnity.org.

Section 3.04a – Methods of Payment, Credit Card Terms and Taxes

Each ticket seller using FirstUnity.org has their own merchant gateway and merchant account services separate from First Unity Spiritual Campus. First Unity Spiritual Campus has no involvement in or between any ticket sales. All ticket sales and transactions involving raffles are between the ticket seller and the ticket purchaser. First Unity Spiritual Campus is only responsible for transactions made through the First Unity Spiritual Campus payment gateway and merchant account services as registered in the name First Unity Spiritual Campus. First Unity Spiritual Campus is NOT an aggregator of transactions or funds in any way, shape or form. All payments must be made by VISA, MasterCard, American Express, Discover, and Diner s Club credit cards each of which may be removed by First Unity Spiritual Campus in its sole discretion. Unless expressly set forth on FirstUnity.org, no other form of payment is accepted. If any other form of payment is offered or accepted, you

hereby agree to all restrictions, terms and conditions associated with such additional form of payment. Your card issuer agreement governs your use of your designated card, and you must refer to that agreement and not this Agreement to determine your rights and liabilities as a cardholder. YOU, AND NOT FIRST UNITY SPIRITUAL CAMPUS OR ANY OF ITS USERS, ARE RESPONSIBLE FOR PAYING ANY UNAUTHORIZED AMOUNTS BILLED TO YOUR CREDIT CARD BY A THIRD PARTY. You agree to pay all fees and charges incurred in connection with your purchases including any applicable taxes at the rates in effect when the charges were incurred. Unless you notify First Unity Spiritual Campus of any discrepancies within thirty 30 days after they first appear on your credit card statement, you agree that they will be deemed accepted by you for all purposes. If First Unity Spiritual Campus or its users do not receive payment from your credit card issuer or its agent, you agree to pay all amounts due upon demand by First Unity Spiritual Campus and its agents or users and their agents. You are responsible for paying any governmental taxes imposed on your purchases, including, but not limited to, sales, use or value-added taxes.

Section 3.05a – Maximum Ticket Count and 50 50

Each raffle held using FirstUnity.org has a maximum ticket sale count. Upon the sale of all tickets for a given raffle, the raffle will be listed as Sold Out until the specified raffle end date is reach. When the end date is surpassed, the raffle will no longer be listed. If the raffle end date is reach before the maximum ticket sale count is reached, you agree that the ticket seller has the right to convert the raffle to a 50 50 style cash raffle where the winner is only entitled to fifty percent of gross ticket sales in place of the original raffle prize offered. If multiple winners are drawn, fifty percent of the gross ticket sales will be divided and distributed equally among the selected winners. You understand and agree that this is at the sole discretion of the ticket seller. You agree that First Unity Spiritual Campus has no involvement in such decisions.

Section 3.06a – Raffle Closure

All raffles are closed on the raffle end date. No additional ticket sales are allowed after the raffle end date. If a raffle is Sold Out before the raffle end date and the ticket seller wishes to change the end date to an earlier date,

written authorization must be attained from the appropriate governing or regulatory agency. The ticket seller must notify all ticket holders of any changes. If a raffle is halted for any other reason, governing law will prevail.

Operation, Management, and Maintenance

Section 3.07a – User Accounts

The operation, management, and maintenance of your FirstUnity.org account and information is your sole responsibility. First Unity Spiritual Campus only provides technical support related to the use of FirstUnity.org and its software.

Section 3.08a – Raffle Operation, Promotion, and Management

First Unity Spiritual Campus does NOT operate, promote or manage any raffles in any way, shape or form. First Unity Spiritual Campus is a for-profit organization that licenses the software FirstUnity.org to its users under the terms and conditions set forth under this Agreement. FirstUnity.org is a licensable web application.

Section 3.09a – FirstUnity.org Licensing and Fees

First Unity Spiritual Campus charges ticket sellers licensing fees for the use of its software FirstUnity.org on a per use basis. Per use for the specific purpose of selling raffle tickets is based on website hosting, bandwidth usage, account activity, technical software support, secure connections, equipment usage, website maintenance, security, and all other costs and expenses placed on First Unity Spiritual Campus in order to provide usage of its software for each individual raffle. These fees are only incurred during active raffles and are designed to offset expenses during inactivity by shared service and utility with

other users. These fees will vary based on the volume of activity created by ticket seller accounts and active raffles.

Compliance with Laws, Rules, and Regulations

Section 3.10a – Legal Compliance

It is your responsibility to be in compliance with federal, state and local laws and regulations. First Unity Spiritual Campus makes no guarantee that you are in compliance with federal, state and local laws or regulations. FirstUnity.org enables you to engage in raffle activity while maintaining legal compliance, so it is your responsibility to ensure that you are in compliance with all applicable laws and regulations when you use FirstUnity.org.

Section 3.11a – Void where Prohibited

You agree to void use of FirstUnity.org where prohibited by federal, state and local laws and regulations. You shall not sell or purchase raffle tickets using FirstUnity.org or use FirstUnity.org in any manner that violates federal, state and local laws and regulations. You release First Unity Spiritual Campus from any liability associated with your use of FirstUnity.org and agree to pay any legal fees or damages caused to First Unity Spiritual Campus by your use of FirstUnity.org.

Section 3b

Member Specific Terms and Conditions

Section 3.01b – FirstUnity.org Membership

First Unity Spiritual Campus offers membership to its users at no charge in consideration of acceptance of membership agreements. Membership is a requirement before any transaction may take place using FirstUnity.org. FirstUnity.org is a closed loop network which requires user registration and login.

Section 3.02b – Types of FirstUnity.org Members

There are six primary types of FirstUnity.org Members; Users, Organizations, Sponsors, Advertisers, Independent Sales and Account Managers, and Regulators. In addition to the standard First Unity Spiritual Campus User Agreement you agree to all the terms and conditions in Section 3b as they apply to your specific account type upon membership registration.

Section 4

Use, Communications and Transmissions

Section 4.01 – Use and Access

First Unity Spiritual Campus hereby grants you a non-exclusive, non-transferable and revocable license to access FirstUnity.org solely for viewing, browsing, retrieving, uploading and posting information, selling and purchasing raffle tickets, and purchasing advertising space on FirstUnity.org, subject to the terms and provisions of this Agreement.

Section 4.02 – Prohibited Use and Communications

First Unity Spiritual Campus prohibits any unsolicited or bulk e-mail transmission to be sent, or caused to be sent, over the Internet, to any FirstUnity.org e-mail address. You may not harvest or collect e-mail addresses from FirstUnity.org for the purpose of sending unsolicited or bulk e-mail. First Unity Spiritual Campus prohibits any e-mail transmission to be sent, or caused to be sent, to any FirstUnity.org e-mail address if the e-mail is intended to, or appears intended to, harass, embarrass, threaten, defame or impersonate any person, or if the e-mail is pornographic, offensive, indecent, discriminatory or offensive on the basis of sex, color, national origin, race, age, religion, sexual orientation or disability. First Unity Spiritual Campus prohibits any e-mail transmission to be sent, or caused to be sent, to any FirstUnity.org e-mail address that makes use of a forged header or deceptive addressing, or which attempts in any manner to disguise the source of the e-mail.
